May 13th 2019 Monthly Board Minutes Jess has a resolution for the Rt 89 road closure. We are closing Rt 89 from Tuesday, September 17th at 5:00 p.m. and reopening it on Sunday, September 22nd at noon. Jess made a motion to approve Resolution R-19-2, Ginger seconded it. All ayes, motion carried.

Webb's Roadhouse has requested permission to shut down Francis St at the Industrial Park on July 20^{th} from 9:00 a.m. – 6:00 p.m. for a bike event they are hosting. Jess made a motion to approve this request, Randy seconded it. All ayes, motion carried.

Jess wanted to pat Matt and Cheri on the back a bit. In the years past, we've had to pay roughly \$5000 to our Engineer to fill out all the paper work to get to spend the MFT money. Matt and Cheri did it themselves this year and we've been approved for \$24,500 MFT. Good Job!

There was a brief explanation of what MFT is and how we can use it.

There was a discussion regarding adding a sidewalk on Parkside Drive from the corner at Park St to the drive way access at the Legion where there is not sidewalk now. The materials would cost approx \$2700 from Roanoke Concrete. Matt and Jared could pour it.

Billy is coming on Monday to fix the spot in front of Sicily's that we approved last month and paid for out of last years budget.

WATER: None.

POLICE: Ginger said we got a bid from someone to fix the roof on the Police Dept from Slagel Installation. The bid includes replacing the roof with spray foam at 1.5" for \$6600. This bid also include some roof sheeting and a fascia board with commercial gutter and one down spout. It also include a 10-year warranty for the spray foam. We have budgeted for this. Ginger made a motion to approve the 1.5" spray foam for \$6600, Jess seconded it. All ayes, motion carried.
