<u>STREETS</u>: We got the new truck. It was mentioned we had a grant to pay for half of the cost of the snow plow mounting and were able to return some parts we didn't need so we did well with the cost of that.

Committee gave permission to Matt to buy some steps for truck for approximately \$200.

Matt asked about decals for the truck. Jeff hasn't heard anything further from his contact. The board mentioned to Matt to check with Simply Signs or Logo Wear.

<u>WATER/SEWER</u>: All the final bills are in for the water plant. Cheri took the final electrical bill out of TIF. We did not have to apply for that loan.

Becky told Matt Winkler's cannot get the dehumidifier filter he asked about. Ed told him of a company in Peoria to check with since it's an odd size.

<u>POLICE</u>: Eric made a motion for a permanent transfer from corporate to police for \$14,100, Pat seconded it. All ayes, motion carried.

Chief called Danny and a guy in Springfield, we have to have an Ordinance on record to let Derek be able to work since he's still going through schooling.

There was a discussion regarding stop sign/yield signs at corner of Crestwood/Hillcrest and Main/South streets. A yield sign needs to be put up at Crestwood/Hillcrest. We will create an ordinance for this.

Jeff have his police report. There were a couple child custody issues. There is also someone that was pretending to be a 15-year old male from Oregon, which is being investigated by Homeland Security.
