Retention of Legal Counsel

WHEREAS, the Citizens of the Village of Washburn have elected, David L. Humphrey as the new President of the Village Board of Trustees (the position more commonly and hereinafter referred to "Mayor"); and

WHEREAS, one of the duties of Mayor is to appoint corporation legal counsel for the Village; and

WHEREAS, the current corporation legal counsel for the Village, Danny L. Schroeder, has served the Village in such capacity for the past fifteen (15) years; and

WHEREAS, both the Mayor and Danny L. Schroeder hereby declare and disclose a potential conflict of interest in that Danny L. Schroeder and his law firm have also served as legal counsel to the Mayor, David L. Humphrey, both in his individual capacity as well as on behalf of the corporation(s) in which David L. Humphrey has held an ownership interest - currently as legal counsel to Central Illinois Consulting, Inc., an Illinois corporation; and

WHEREAS, the Mayor wishes to officially nominate and, with the board's concurrence, appoint Danny L. Schroeder as corporation legal counsel for the Village; and

WHEREAS, the Village Board of Trustees believes the appointment of corporation legal counsel for the Village must not be taken lightly and must be done with the adequate due diligence which is required.

WHEREAS, in order for the Village Board of Trustees to effectively waive any conflict of interest that may exist in order for Danny L. Schroeder to continue to serve as corporation legal counsel for the Village, the Village Board of Trustees must have received full disclosure of any conflict of interest and must be convinced that Danny L. Schroeder will be able to continue to loyally serve the Village of Washburn in his capacity as corporation legal counsel wholly free of any undue influence on the part of any other person or entity, including, but not necessarily limited to, the new Mayor, David L. Humphrey, and his company for whom Danny L. Schroeder and his firm intend to continue to provide concurrent and separate legal representation.

THEREFORE, BE IT RESOLVED, the Village Board of Trustees acknowledges receipt of the above disclosure of the conflict of interest and has taken such steps and performed such due diligence as deemed necessary to ensure the Board of Trustees collectively, and each of the Trustees individually, that the disclosure is complete and accurate; and

BE IT FURTHER RESOLVED, that the Village Board of Trustees has voted to waive the conflict of interest and to concur in the appointment of Danny L. Schroeder and his law firm of Hasselberg, Rock, Bell & Kuppler LLP as corporation counsel for the Village of Washburn, Illinois and to

Resolution No. R-09-03

PREVAILING WAGE RESOLUTION

WHEREAS, the State of Illinois has enacted "An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city, or any public body, or any political subdivision or by any one under contract for public works," approved June 26, 1941, as amended (Illinois Compiled Statutes, Ch. 820, par. 395-1 et seq.); and

WHEREAS, the aforesaid Act requires that the Board of Trustees of the Village of Washburn investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Village of Washburn employed in performing construction of public works, for said Village of Washburn.

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WASHBURN:

SECTION 1: To the extent and as required by "An Act regulating wages of laborers, mechanics and other workers employed in any public works by State, county, city, or any public body or any political subdivision or by any one under contract for public works" approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Village of Washburn is hereby ascertained to be the same as the prevailing rate of wages for construction work in Woodford and Marshall Counties area as determined by the Department of Labor of the State of Illinois as of June, 2009, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor and of the State of Illinois shall supersede the Department's May determination and apply to any and all public works construction undertaken by the Village of Washburn. The definition of any terms appearing in this Resolution which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Village of Washburn to the extent required by the aforesaid Act.

SECTION 3: The Village of Washburn Clerk shall publicly post or keep available for instruction by any interested party in the main office of the Village of Washburn this determination or any revisions of such prevailing rate of wage. A copy of this determination or of the current revised determination of prevailing rate of wages then in effect shall be attached to all contract specifications.

SECTION 4: The Village of Washburn Clerk shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The Village of Washburn Clerk shall promptly file a certified copy of the Resolution with both the Secretary of Sate Index Division and the Department of Labor of the State of Illinois.

SECTION 6: The Village of Washburn Clerk shall cause to be published in a newspaper of general circulation within the area a copy of this Resolution, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
