U.S. Postal Service Representative is here to discuss the permanent post office site for the main post office for Washburn.

Marla Larson Williams is here tonight to let us know the post office is going to be relocated to 139 Jefferson St. The current location would not re-new there lease. This new location is temporary, the postal service is looking for a permanent

location it must at least 900 sq. feet w/off street parking or a vacant site for building. If you have land it must be at least 1400 square feet of property, or a building in the preferred area you can submit your building or vacant lot to the postal service on the correct form which is available at our current post office location. Then they will contact the village and let them know what properties that have been submitted. They would like to stay downtown and they are looking for a 20 yr lease. A new building takes about 2yrs and an existing building takes about 18 mos. The rent they pay is market and they pay there own utilities.
