AN ORDINANCE AMENDING PRIOR ORDINANCES TO REFLECT THE CHANGE IN POLICE STATUS IN THE VILLAGE OF WASHBURN

PASSED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF WASHBURN, ILLINOIS ON MAY 10, 2021

WHEREAS, the Village Board of Trustees of the Village of Washburn have adopted certain ordinances codified in the Village of Washburn Code of Ordinances, and

WHEREAS, the Village of Washburn no longer employs a Police Chief or Police Department, and

THEREFORE, BE IT ORDAINED by the President of the Board of Trustees of the Village of Washburn that the Village of Washburn Code of Ordinances ("Ordinances") are hereby amended to read as follows:

TITLE XIII GENERAL OFFENSES §130.10(F) STORAGE OF JUNK IN RESIDENTIAL AREAS is hereby changed and amended as follows:

(F) Notice to Abate. The Zoning Officer is hereby authorized and empowered to notify the person in control of any private property to relocate any inoperable vehicles parked or store in violation of this section to a completely enclosed location on the property or otherwise to remove the same from the premises. Said Zoning Officer is also hereby authorized and empowered to notify the person in control of any private property to relocate any motor vehicle bodies, parts, equipment, motors, and materials stored, placed, or allowed to remain in the open in violation of this section to a completely enclosed location on the property or otherwise to remove the same from the premises. Such notice shall be given by certified or registered mail addressed to the residence or usual pace of business of such person, or may be posted on the premises where the violation exists.

TITLE XV: LAND USAGE §150.09 BUILDING REQUIREMENTS; CONSTRUCTION NON-CONFORMANCE is hereby changed and amended as follows:

Any violation of this subchapter shall first result in a verbal or written warning issued by the Zoning Officer. If the violation has not been corrected within four calendar days after the date of the verbal or written warning, the Zoning Officer may, by written directive, order the owner, tenant, or other person in possession of the property upon which the swimming pool is located to drain the swimming pool until the violation is corrected.

BE IT FURTHER ORDAINED that nothing contained herein shall be construed to rescind or limit provisions other than the above enumerated Ordinances of the Village of Washburn together with amendments and additions thereto, passed prior to this date; further that this be and shall be and are the only amendments to the aforesaid Ordinances and all provisions of said Ordinances and amendments thereto which are not conflicting with the provisions of these Ordinances are hereby ratified and confirmed and shall continue in full force and effect.
