**ORDINANCE NO. 21-02**

**TAX LEVY ORDINANCE OF THE VILLAGE OF WASHBURN, ILLINOIS**

**PASSED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES  
OF WASHBURN, ILLINOIS**

**ON DECEMBER 13, 2021**

AN ORDINANCE making the tax levy for all corporate purposes for the **Village of Washburn** of WASHBURN, ILLINOIS, for the fiscal year commencing the 1st day of May, 2022 and ending the 30<sup>th</sup> day of April, 2023.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF WASHBURN, ILLINOIS:

SECTION 1: That a tax for the following sums of money, or as much thereof as may be authorized by law, to defray expenses and liabilities of the Village, be and the same is hereby levied for the purposes thereafter specified against all the taxable property within the corporate limits of the VILLAGE OF WASHBURN of the fiscal year commencing on the 1st day of May, 2022 and ending the 30<sup>th</sup> day of April 2023.

SECTION II: The amount of tax levies for each object and purpose is as follows:

CORPORATE	\$ 35,862
ROAD & BRIDGE	6,133
POLICE	\$ 8,077
SOCIAL SECURITY	\$ 16,510
INSURANCE	\$ 47,878
AUDIT	\$ 17,913
ESDA	\$ 720
STREET LIGHTING	\$ 2,890
GARBAGE	<u>\$ 4,097</u>
	\$140,080

SECTION III: The clerk of said Village shall file a duly certified copy of this ordinance with the County clerks of Marshall and Woodford Counties, and in accordance with the laws of the State of Illinois pertaining thereto, in order that the said sum of \$140,080 may be levied and extended by said County clerks on the tax books for the said year for village purposed, respectively, and the taxes collected in the manner provided by their general revenue laws of the State of Illinois.


SECTION IV: That all sums of money not needed for immediate purposes may be invested in securities of the Federal Government in federally insured Savings and Loan Associates or in Certifications of Deposit of any banks defined in the Illinois Banking Act.

SECTION V: Partial Invalidity: If any section, subdivision, or sentence of this ordinance is for any reason held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION VI: This ordinance shall be in full force and effect from and after its passage and approved as provided by law.


