ORDINANCE NO. 2023-2

**THE VILLAGE OF WASHBURN, ILLINOIS, AMENDS ORDINANCE NO. 1995-3
TO CORRECT SCRIVENER'S ERROR**

BE IT ORDAINED by the Mayor and the Village Board of Trustees of the Village of Washburn, Woodford County, Illinois, as follows:

WHEREAS, in Ordinance No. 1995-3, the Mayor and the Village Board of Trustees of the Village of Washburn declared it is to the best interests of the Village of Washburn that an approximately 0.218 acre section of Washington Street between a 20 foot wide alley and Woodford Street be vacated pursuant to 65 ILCS 5/11-91-1; and

WHEREAS, in Ordinance No. 1995-3, the Mayor and the Village Board of Trustees of the Village of Washburn declared it is to the best interests of the Village of Washburn that it reserve and retain the right to maintain, operate, repair and replace, by itself or by any agent, licensee or a holder of a franchise from the Village, any poles, wires, pipes, conduits, sewer mains, water mains, or any other facility or equipment for the maintenance or operation of any utilities that now may be located, or may later be desired by the Village, in the street, vacated by this ordinance; and

WHEREAS, in Ordinance No. 1995-3, the legal description of said section of Washington Street therein described omitted a measurement due to scrivener's error;

NOW, THEREFORE, BE IT ORDAINED by the Village Board of the Village of Washburn, Woodford County, Illinois as follows:


The operative provision of Ordinance No. 1995-3 shall be amended to state:

That a part of Washington Street in McCulloch's Addition to Washburn, Illinois, being a part of the N.W. Quarter of Section 1, Township 28 North, Range 2 West, of the Third


Principal Meridian, Woodford County, Illinois, more particularly described as follows: The Point of Beginning being the Northwest corner of Block 6 of McCulloch's Addition, thence South 158.00 feet along the West line of Lot 4 of Block 6, thence South 89°-27'-05" West 60.00 feet, thence North 158.00 feet along the East line of Lot 1 of Block 5, thence North 89°-27'-05" East 60.00 feet to the Point of Beginning, is hereby vacated, reserving unto the Village across, above, over or under the Western 25 feet of even width from the center line of the alley to Woodford Street a distance of 158.00 feet, more particularly described as follows: From the Northwest Corner of Block 6 of McCulloch's Addition South 158.00 feet along the West line of Lot 4 of Block 6, thence South 89°-27'-05" West 35.00 feet to the Point of Beginning, thence South 89°-27'-05" West 25 feet, thence North 158.00 feet along the East line of Lot 1 of Block 5, thence North 89°-27'-05" East 25 feet, thence South 158.00 feet to the Point of Beginning, the right to maintain, operate, repair and replace, by itself or by any agent, licensee or a holder of a franchise from the Village, any poles, wires, pipes, conduits, sewer mains, water mains, or any other facility or equipment for the maintenance or operation of any utility that now may be located, or may later be desired by the Village.
