#### AN ORDINANCE TO CHANGE AN UNNAMED STREET TO WILDCAT LANE

**WHEREAS,** the Village of Washburn, Illinois ("Village") has the authority to name, and then may change, the name of any street, avenue, alley, or other public place as set forth by 65 ILCS 5/11-80-19; and

WHEREAS, the street between, and parallel to, N Francis St and County Road 1400E is not named ("No Name Road"); and

WHEREAS, for illustrative purposes, No Name Road is located where denoted on Exhibit A (near Low Point-Washburn Middle and High School); and

WHEREAS, the Village desires to name No Name Road.

# NOW THEREFORE, BE IT ORDAINED BY VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF WASHBURN, ILLINOIS, THAT:

- 1. The recitals set forth in the preamble to this Ordinance are hereby incorporated by reference as if fully set forth herein.
- 2. No Name Road (located as set forth on Exhibit A) shall hereby be named Wildcat Lane.
- 3. As set forth by 65 ILCS 5/11-80-19, this Ordinance shall be effective 30 days after the Village notifies the election authorities having jurisdiction of No Name Road and the post office branch serving No Name Road of the name change via certified mail.


