Guest Speaker:

Autum Jones, Manager of Woodford County Farm Bureau was present at tonight's meeting to ask for Villages support/resolution in Woodford County. There are roughly 3,500 Farm Bureau Members, with roughly 1,000 in just Woodford County alone, she is not asking for any special treatment, just Ag support as Woodford County as come of the riches soil. Ginger made a motion to adopt resolution seconded by Randy – Roll Call Vote – Kevin Yes, Ed Yes, Kris Yes, Ginger Yes, Randy Yes, Becky Yes – 5 Ayes 0 Nay Motion Carried.

STREETS:

Frank sent oil and chip estimate to Ginger - \$76,169.40 (including \$10,000 in spray patching on top) bid not out yet.

Walker is ready to start the water like to Dollar General on Wednesday

There was discussion regarding Francis Street and Oblique street being a concern (to be looked at for this year's budget)

WATER AND SEWER:

Ordinance 25-03: Setback for Protection of Water Well – drafted as Metamora's states. Min/max setback may perform ground water assessment (gravel/soil type). Randy made a motion to accept Ordinance 25-03 as written by Village Attorney seconded by Ginger – Roll call vote: Ed Yes, Kevin Yes, Becky Yes, Kris Yes, Ginger Yes, Randy Yes. 6 Ayes 0 Nays Motion carries.

Britton emergency repair: manual bypass of the water tower (flip switch) – boys fill the water tower twice a day. – times cards may reflect some overtime due to this repair and manual bypass. Tower panal was struck by lighting for the second time, no more than \$60,000 to repair – it's been a challenge to get a good ground.
